### The Fund

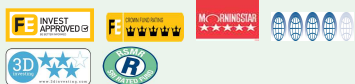

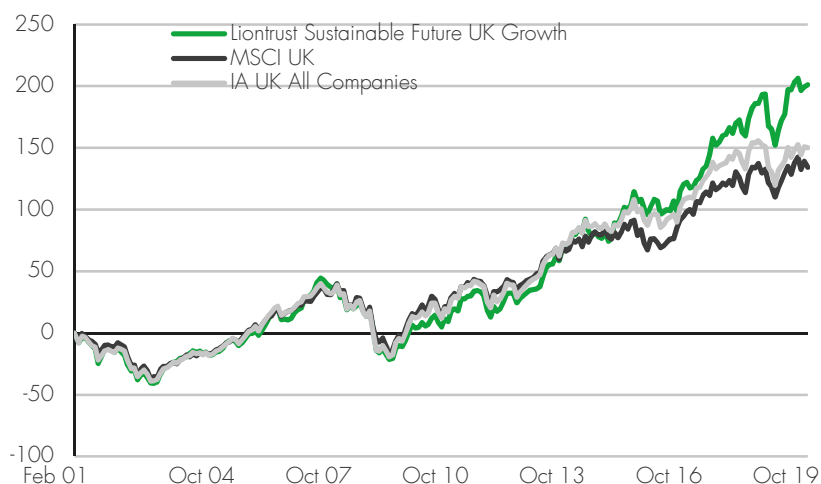
