This document provides you with key investor information about this Fund. It is not marketing material. The information is required by law to help you understand the nature and the risks of investing in this Fund. You are advised to read it so you can make an informed decision about whether to invest.

Liontrust Macro Equity Income Fund is an Authorised Unit Trust and categorised as a UCITS scheme. This document is based upon Institutional class units (I Acc Class) (ISIN: GB00B88W5T75). This Fund is managed by Liontrust Fund Partners LLP, a subsidiary of Liontrust Asset Management PLC.

Objective

- To provide a rising level of income with some capital growth by investing in UK and overseas companies. It is intended that the target yield will be in excess of 110% of the yield of the FTSE All-Share index each year.

Policy

- In providing an above average level of income, particular attention will be paid towards capital preservation.
- The Fund invests at least 80% in UK companies together with some international companies.
- Income from this class' investments is accumulated. Income from the other Fund's classes can be paid out, reinvested or accumulated.

Recommendation

- This Fund may not be appropriate for investors who plan to withdraw their money within 5 years.

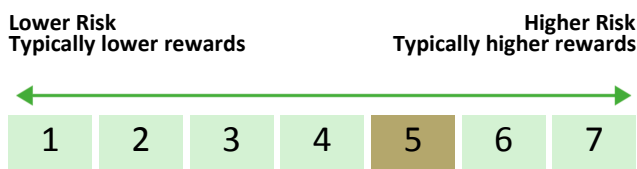
How to buy

- You may buy or sell units on a daily basis (but not weekends or Bank Holidays). Orders must be received by 12:00 midday for execution at 12:00 midday valuation point on the same day. Further details can be found at www.liontrust.co.uk/How to invest.

Investment process

- The investment philosophy is based on the belief that macro-thematic analysis – the identification and interpretation of major economic, political and social developments affecting the UK and the rest of the world – offers scope to add long-term investment value. The fund managers actively seek sources of asymmetric information, views and opinions to support the identification and evaluation of potential investment themes. Identifying such themes, and assessing their implications for investment markets and individual industries, provides the framework for the construction of the portfolio. As a result, sector exposures in the Macro funds may differ significantly from those of the market and many of their sector peers.
- The team monitors potential macro-themes as they evolve, continuously reviewing both their core sources of information and any new sources that may acquire relevance.
- Once a potential investment theme has been identified, the fund managers draw up a potential list of companies to invest in by:
 - evaluating the types of business that might benefit or be disadvantaged by the theme
 - analysing companies' business models; and
 - reviewing management's strategy and outlook.
- This is followed by the fund managers applying fundamental valuation techniques to generate a ranking of companies under each theme to be included in their portfolios.

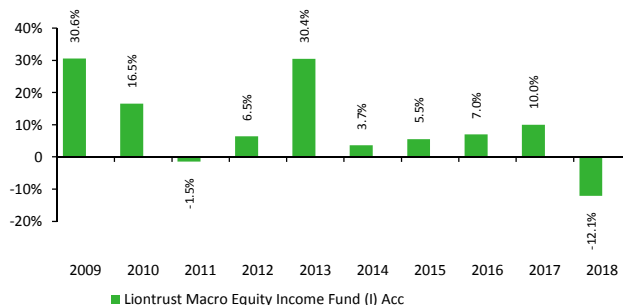
