### Objective and Investment Policy

#### Objective

- To generate income with the potential for long term (5 years or more) capital growth.

#### Strategy

- The Fund invests in a concentrated portfolio of 20-40 companies that may provide growth opportunities or attractive valuations.

#### Investment Policy

- The Fund invests at least 80% in companies across the world. The Fund may also invest up to 20% in other eligible asset classes as detailed within the prospectus. Investors can compare the performance of the Fund against the MSCI ACWI Index. This index is a relevant potential performance comparator for investors because of the similarity of the investment universe.
- Any income the Fund generates will be reinvested to grow the value of your investment.

Recommendation: This Fund may not be appropriate for investors who plan to withdraw their money within five years.

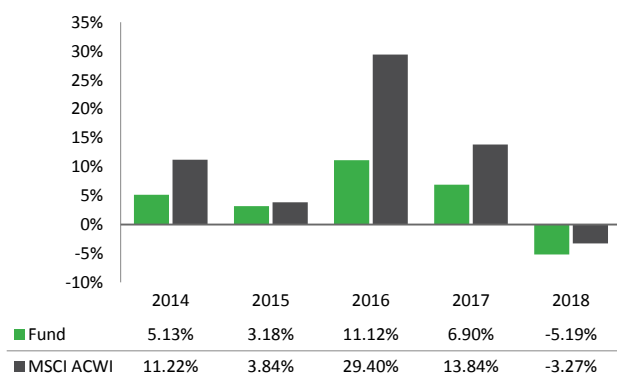
